4. Enrollment Projections

Mr. Zuba and Ms. Augur presented the Committee with the Enrollment Projections they had developed as part of their work.

There is an overall trend in Connecticut that shows school enrollments decreasing. A closer look at the two communities showed a similar decline in the school age enrollments.

The degree of accuracy, from their previous analysis, was within 1% per year.

A review of the enrollment history in the State and in the District was discussed.

The analysis, and their projections, included reviewing the independent enrollment studies conducted by Dr. Prowda and NESDEC.

The enrollment projections are included in the report, which is posted on the R15 web-site.

The next phase is the education program review, and space needs. This will be done in the next couple of weeks, and then a review of the future needs and changes in program delivery will be incorporated in the Space needs for the future.
